Introduction to Financial Statements & Budget

The following notes provide context for our financial report and proposed budget.

- We use the Budget Headings: **Connecting People to God, to Each Other & to the World**. *This method of organizing our budget helps ensure that our financial priorities are consistent with this core mission.*
- The percentage of Bethany's Proposed General Fund Budget allocated to Debt Service is 15%. This is down from nearly 50% in 2002, our first full year in this building.
- This year's Proposed General Fund Budget represents an increase of 2.8% from our 2021 General Fund income and a 2.8% decrease from our 2021 budget.
